We may disclose your personal information to our related bodies corporate and service providers, including those located in the USA and Singapore. We also de-identify and aggregate your data for market research and data analytics purposes. Terms and Conditions

1. To enter the Promotion, Entrants must, during the Promotion Period:
 - a. visit any participating Shopping Centre named in Schedule 1 and visit the iPad Promotion kiosk in that Shopping Centre; or
 - b. visit the Promotion webpage on the website of a Shopping Centre (as listed in Schedule 1); and submit the requested details for a chance to win (each an **Entry** and collectively the **Entries**).
2. Multiple Entries are permitted from the one person and the one email address. However, there is a daily limit of one Entry per email address per day.
3. General

6. The Promotion shall run from the Start Date and Time to the End Date and Time (**Promotion Period**) and is promoted by the Promoter on behalf of the Shopping Centres. The Promotion is not valid in conjunction with any other offer.
7. All entrants (**Entrants**) acknowledge and agree that their entry into the Promotion is subject to, and they must adhere to, these terms and conditions and any additional terms and conditions or alterations to these terms and conditions as set out by the Promoter from time to time. Information about Prizes and how to enter forms part of these terms and conditions. Entries not in accordance with these terms and conditions are invalid. The Promoter may, at any time, require Entrants to produce documentation to establish to the Promoter's satisfaction the validity of Entries (including receipts and documentation establishing identity, age, place of residence and place of employment of Entrants). Failure by the Promoter to enforce any of its rights at any stage does not waive those rights.
8.
