

VICINITY MALL SPACE PRIVACY NOTICE

Vicinity Centres includes Vicinity Real Estate Licence Pty Ltd ABN 39 060 482 635 and Vicinity Centres PM Pty Ltd ABN 96 101 504 045 ('Vicinity', 'We' or 'us'). Personal information which we collect as part of mall space licensing arrangements may include:

- for actual or prospective licensees ('Licensee') or Licensee directors: name, address, date of birth, contact and insurance details, job position, identity verification documents; and
- for Licensee personnel: name, job position, contact details and any other information required for registering such personnel for centre services, such as online tenancy/licensee management or retailer carparking.

We collect this information in order to:

- assess licensing applications (including by conducting identify verification and assessing the commercial risk for Vicinity-managed shopping centre owners in granting you a licence);
- if we accept a licensing application, provide mall space licensing and related services (including access to utilities, licence administration and payment processing);
- manage relationships with Licensees (including agreements and communications with them);
- comply with applicable laws and requirements of government agencies with respect to such licensing;
- operate centres in which space is licensed and monitor their risk profile and performance (including by conducting market research and analysis on de-identified and aggregate data);
- understand Licensee interests and activities at our centres so as to improve Licensee experience at our centres; and
- contact Licensees with further information about our retail mall solutions or in the event of an emergency.

We may also share this information with:

- our lawyers, mortgagees, insurers as well as tenancy tribunals, courts and government agencies where required for the purposes of managing licensing arrangements;
- Licensee referees and workplaces for verifying information supplied as part of licensing arrangements;
- the relevant property owners for approval or rejection of licensing arrangements as well as subsequent owners and managers of the centres in which space is licensed; and
- service providers who assist us in providing licensing-related services, including credit reporting agencies such as Equifax, which we use to conduct company and director searches.

The information which we request as part of the licensing process is necessary for us to form a balanced view of licensing applications which are made and manage your licensing relationship with us. Without the details requested, we may not be able to grant you a licence. By supplying this information, you are deemed to have provided and obtained the necessary consents required for us to handle the information which you have supplied in the manner described above.
